Appointment of LEA Governors

1. <u>Purpose</u>

The purpose of this report is to request that the Panel appoint LEA Governors to the named Governing Bodies.

2.1 Recommendations

The Panel is asked to appoint LEA governors to the named governing bodies for a four year period (unless otherwise stated) or until the introduction of a New Instrument of Government arising from the Education Act 2002, whichever is sooner.

Explanatory Notes

*An asterisk indicates that a letter regarding the nomination has been received from the school. This has been circulated for consideration to the three political spokespersons for the Panel.

Governing bodies have to be re-constituted during the period 1st September 2003 to 31st August 2006 under the provisions of the Education Act 2002.

N- indicates the Governing Body has been constituted or re-constituted under the provisions of the Education Act 2002. The transitional arrangements under the regulations made under that Act are a little complex and affect, for example, periods of office. A letter has been sent to all schools explaining this and is appended, Appendix 1, for the information of the Panel.

Dear Colleague,

Governors' Periods of Office

We are intending to send a report to governing bodies explaining the new governing body procedures, which come into effect from 1st September 2003. There will also be training available in the new procedures available as part of the Governor Support Service Level Agreement. However we have recently received a number of telephone enquiries regarding Governors' periods of office and are therefore sending this letter containing advice received from DfES.

All Governors elected or appointed **on or before 1st September 2003** serve out their term of office until it ends, or up to 31st August 2006, whichever is the earlier.

The exception to the above is Nursery Schools who are establishing their Governing Bodies for the first time. The periods of office for Nursery School Governors will therefore be from 1st September 2003 for the relevant period stated in the Instrument of Government.

Governors elected or appointed on or after 2nd September 2003 under a New Instrument will serve out their full term of office as stated in the Instrument of Government.

Governors elected or appointed on or after 2nd September 2003 under the Old Instrument of Government will serve until the date of reconstitution, which will be no later than 31st August 2006.
