Social Care Year-end Performance and Benchmarking

Executive Summary:

This report outlines Walsall's final 2017-18 performance for children's social care for key indicators compared with the previous two-years from the two key statutory returns that are submitted to the Department for Education each year (the CLA 903 which details information about Looked after Children and the CiN Census which details information about children in need and child protection)

The report also includes the benchmarking data released by the Department for Education, which shows Walsall's performance against statistical neighbours (those local authorities that are most like Walsall in key demographic and economic indicators), the 14 local authorities in the West Midlands region and the national, England average.

The report out-lines a significant increase in demand in 2017-18 for social care services and increases in the number of children who are subject of a child protection plan. Despite the increase in demand, performance in respect of timeliness of assessments and initial child protection conferences remains good.

Also, despite increasing demand, the number of looked after children continues to fall and placement stability and distance looked after children are placed from home is improving. Outcomes for looked after children and mixed, with improvements is some areas and decline in others.

Outcomes for Care Leavers have improved significantly and performance for this cohort is good across the board.

This report is being presented to scrutiny to confirm the council's 2017-18 out-turn performance and highlight Walsall's performance compared with the 2016-17 out-turn and comparators.
