The business requirements for this case is the continued provision of a Direct Payment Support Service (DPSS) to enable provision of Personal Budgets to service users eligible to manage their care procurement and financial management through a Direct Payment. What is the intended outcome? The purpose of this proposal it to award a new framework for the provision of DPSS services, for a period of three years, with the option to extend on an annual basis for a further period of up to two years, which will replace the existing framework which ends on 5 October 2021. Reasons for change? The existing framework ends on 5 October 2021, but a 6 month extension is being requested. Furthermore as the current combined value of this exiting framework is in the region of £330,000 per annum for Adult Social Care and Children's Services, EU Procurement Regulations and the Council's current | | | | |
