Context

Many people are talking about outcomes in social care, but what does this mean? Are they confusing outcomes with outputs or processes?

These confusions create fundamental problems for councillors seeking to scrutinize performance in adults' and children's services. This is perhaps not surprising when considering that performance management and measurement can all too often seem remote, with a danger that both members and officers are swamped in data that provides little or no meaning. Members can easily become frustrated by the reactive nature of measuring outputs, rather than driving improvement based upon outcomes.

Performance in adults and children's services needs to be based on leadership and management, and not just on measurement. Responding to the broader concepts involved in managing performance problems will enable members to participate proactively in improving council services.

Seminar overview

For members and officers involved in scrutiny, understanding outcomes is essential to providing oversight to council policy development and practice. It is often too easy to think about oversight in terms of outputs. Coupled to this, we will also consider the implications of the developing world of performance outcomes in light of the recent Local Government White Paper proposals for Comprehensive Area Assessments and clarity about nationally and locally joined up outcomes.
