100. **Apologies**

101. **Minutes**

**Resolved**

102. **Declarations of interest**

103. **Mayor's announcements**

(1) **Death of Baroness Thatcher**

As a mark of respect members and officers stood in silence in memory of the late former Prime Minister, Baroness Thatcher.

(2) **Councillor Oliver**

The Mayor welcomed Councillor Oliver to the meeting following his recent surgery.

(3) **Night shelter**

On behalf of the Council, the Mayor thanked the volunteers of the Hi's and Low Charity for providing food and shelter to homeless people during the recent cold spell.

(4) **Drinks**

As this was the last ordinary meeting of the municipal year, the Mayor invited members to join him in the Mayor's Parlour for drinks.

## 105. **Questions by members of the Council**

### (1) **Beekeeping schemes**

Councillor James asked the following question of Councillor Harris:

"The importance of 'Pollinators' has in recent years, become a topic at the forefront of countryside and conservation issues in the media. Councils across the UK and many conservation organisations now recognise the vital role 'Pollinators' (including wild bees and butterflies, domestic honey bees) play in our natural landscape. These insects contribute significantly to plant and crop yields, and ensure the pollination of many species of wild flowers, which are in steep decline.

The Greenspace Services Allotments Strategy 2007 - 2012, hopefully soon to be updated, includes sections on 'Areas Managed for wildlife' and 'Promoting Partnership working with groups promoting food production and Biodiversity' amongst its aims. However, Appendix 3 Allotment Tenancy Agreement Section 2(g) states allotment holders are "Not to keep upon the allotment any pigs, fowl or other livestock".

Could the portfolio consider an amendment to this policy to clarify that honey bees be considered exempt from the catch-all 'livestock' provided that any beekeeping schemes be undertaken as in the Governments 'Growing in the Community' document , in partnership with the British Beekeepers' Association?"

Councillor Harris replied that the Council recognised the need to update the agreement to provide something which was more user-friendly and which reflected current social, economic and environmental issues. In October last year Council officers advised all tenants on allotment sites directly managed by the Council, of the aim to renew the tenancy agreement during 2013/14 and 12 months notice was required under allotment legislation. We will be meeting with allotment associations during the consultation on this.

He said that following enquiries from allotment tenants a feasibility study of bees on allotments was approved. This started last year with a trial of three families of bees on the Cartbridge Lane Allotments and this trial was continuing this year. Anecdotal evidence suggested that as well as environmental benefits, crop yields on the site increased.

Officers have also sought advice from the British Beekeepers Association on how the Council can support beekeeping on allotments. The advice was to establish a new policy and agreement for tenants, to ensure that animal welfare regulations are met, including membership of a beekeeping association, and a

system of monitoring on sites without associations. This was the intention, subject to the consultation with allotment holders.

Councillor Harris said that he would keep Councillor James updated as work on this progressed.

(2) **Spending on footpaths and highways**

Councillor Young asked the following question of Councillor Ansell:

“Can the portfolio holder give a ward by ward breakdown of the total spend on footpaths and highways since April 2012 to date?”

Councillor Ansell said that following Cabinet approval in April 2012 the Council had published its three year Highway Maintenance Programme on the website, together with the Highway Maintenance Strategy, for the period 2012 to 2015.

This programme had been put together based on engineering need taking into account information from various sources, including engineer’s programme inspections, condition and survey data, highway inspectors, members of the public, Councillors, area managers and the risk and insurance service.

Councillor Ansell said the planned highway maintenance expenditure for 2012 to 2013 broken down on a ward by ward basis had been circulated around the Council Chamber, together with another plan which gave a breakdown for the full six year period between 2007 and 2013 inclusive (copies appended to these minutes).

(3) **The Lea, Blakenall**

Councillor Phillips asked the following question of Councillor A. Andrew:

“In the light of recently announced austerity measures, can the portfolio holder justify to this Council and especially to the residents of my ward Bloxwich East the recently announced £42,000 of Walsall Tax Payers money to be spent on a piece of scrub land in Blakenall known as the Lea.”

Councillor Andrew replied that Friends around the Lea were Bloxwich East residents and were opposed to housing development on the land despite proposals to develop the site for housing. The £42,000 was made up of £23,000 from Section 106 monies and £9,000 approved through the Area Partnership process (Bloxwich/Blakenall/Birchills/Leamore) and Walsall regeneration of £6,000. He said that it was proposed to support residents and protect the area.

Councillor Phillips asked the following supplementary question:

Could the portfolio holder confirm that Bloxwich East will get the same funding forwarded to them for work to damaged verges opposite St. Peter's School, Bloxwich and at the bottom of Livingstone Road; if there was funding for use on land in that manner, why couldn't a car park be provided on Lower Farm after the Neighbourhood office was demolished?

Councillor Andrew said that Councillor Phillips served on the Project Reference Group in Goscote, the 2 sitting Blakenall Councillors did not have a place and local resident's views were taken into consideration. The issue relating to grass verges needed to be taken up with the highways section.

(4) **Illegal scrap metal trading**

Councillor Young asked the following question of Councillor Ali:

"In a public protection report given to Council on the 7th January 2013, the report quoted "improving support for residents affected by illegal scrap metal trading" Could the portfolio holder tell this Council, what these supportive measures are?"

Councillor Ali said that he had given a written reply to Councillor Young earlier in the year. He said that a wide range of measure had been implemented to tackle this problem including:

- Operation Steel to apprehend illegal scrap metal dealers
- Extensive communications including reports on local TV news and the production of a video
- An e-petition to halt cash sales of metal, gathering over 55,000 signatures
- A pilot project to replace metal gulley and manhole covers with plastic alternatives
- Operation Tornado where visits occur to inspect every scrap metal dealer to ensure they are fully compliant with the legal requirements of their trade
- Promotion and use of smartwater products to deter metal thefts
- Use of CCTV cameras in hot-spots to gather evidence to support enforcement.

These actions demonstrate how importantly the Council was taking this issue and hopefully provided some reassurance to residents. A positive impact was being made, activities taken by the Council and its partners had resulted in scrap metal thefts being reduced by over 50% in Walsall over 18 months. Councillor *Ali* said that the Council would continue efforts to tackle the problems caused by illegal metal trading and the effects on local communities. He was confident that these measures would be successful in North Walsall.

Councillor Young asked the following supplementary question:

Can Councillor Ali provide information as to the number of properties against which the Council has taken enforcement action?

Councillor Harris said that the system was robust and information would be available to allow successful enforcement to be made.

(5) **Gritting on Sunday 24 March**

Councillor Phillips asked the following question of Councillor Ansell:

“Can the portfolio holder tell me what time the gritters were sent out on Sunday 24th March?”

Councillor Ansell replied that the gritters were called out at 9.00 a.m. on Sunday 24th March and continued all day. This followed extensive gritting and snow ploughing prior to the weekend. The teams had been out gritting all Thursday night, completing three gritting and ploughing runs. They were then out again on Friday night and completed another three gritting and ploughing runs continuing through Saturday and finishing about 3.00 p.m.

He said that the forecast for Saturday night and Sunday morning was for light snow flurries. However, snow was heavier than expected and coupled with the winds caused drifting of 8 feet in places. After gritting throughout Sunday, a JCB was utilised on Monday to help clear snow in locations where ploughs were not effective. Gritters were deployed for the remaining school routes. Chester Road was bad but was dealt with well. On Tuesday gritters were used to clear roads in advance of household waste collections. Council and Tarmac operatives cleared snow by hand from footpaths within the town centre and district centres.

Councillor Phillips asked the following supplementary question:

Which route did they set out on, buses from Bloxwich had difficulty getting to Walsall – there were no gritters?

Councillor Ansell said he would give Councillor Phillips the information. We gritted in areas that we would not do normally. Councillor Phillips should be ashamed attacking the workforce who had worked hard to keep roads open.

The report to Licensing and Safety Committee was submitted.

It was **moved** by Councillor Sears, duly seconded and:

(1) That in pursuance of the powers conferred upon it by virtue of Section 3 of and Schedule 4 to the Local Government (Miscellaneous Provisions) Act, 1982 the Council hereby makes the following designation, such designation to take effect on 31st May, 2013 and that the Regulatory Services Manager be authorised to make the necessary statutory advertisements:

(a) The streets within Walsall Town Centre are designated licence streets.

(b) Walsall Town Centre is defined as an area including and edged by the following streets:

Blue Lane West from the junction of Wolverhampton Street to Green Lane;

The line of the Ring Road from the Blue Lane/Green Lane junction to Littleton Street West/Wisemore junction;

Littleton Street West from Wisemore to Hatherton Street;  
 Littleton Street East from Hatherton Street to Lichfield Street;  
 The line of the Church Hill Ring Road from the Littleton Street  
 East/Lichfield Street junction to the Ward Street/Walhouse  
 Road junction;  
 Lower Rushall Street from Walhouse Road to Ablewell Street;  
 Upper Rushall Street from Ablewell Street to High Street;  
 The line of the Church Hill Ring Road adjoining Peal Street and  
 Dudley Street from High Street to Caldmore Road;  
 Vicarage Place from Caldmore Road to Bradford Street;  
 A line from the Vicarage Place/Bradford Street junction to Long  
 Street/Bridgeman Street junction;  
 Navigation Street and Upper Navigation Street from Bridgman  
 Street to the Canal Arm;  
 A line along the Canal Arm and through the old Public Works Depot  
 to the Wolverhampton Street/Blue Lane West junction.

- (2) That any previous resolution passed under Schedule 4 paragraph 2 of the Local Government (Miscellaneous Provisions) Act 1982 designating a street be rescinded in so far as it relates to Walsall Town Centre as defined above.

113. **Notice of motion – Collective fuel switching**

The following motion, notice of which had been duly given was **moved** by Councillor I. Shires and seconded by Councillor Cook:

- (1) This Council notes with concern:
  - (a) the recent increases in household energy bills averaging over 7% per annum given the impact that this will have on many hard pressed households across Walsall MBC
  - (b) that the primary reason for the rise is the increase in fossil fuel prices on gas and electricity tariffs.
- (2) This Council welcomes:
  - (a) the action which the Coalition Government is taking to reduce reliance on fossil fuels in our energy mix long term but believes that action should be taken where possible to increase competition in the retail energy market in order to help drive down bills and get the best deal for the consumer.
  - (b) the initiative of the Department of Energy and Climate Change to promote guidance on collective switching and its launch of a competition to encourage local authorities and community groups to support collective switching schemes.
- (3) This Council further notes that pilot schemes promoted by local authorities in Cornwall, South Lakeland and Oldham have already led to households reducing their energy bills by up to £200 per annum.
- (4) This Council instructs officers to bring forward proposals for Walsall Metropolitan Borough to introduce a collective switching scheme (working with other local authorities and public sector bodies if appropriate) to enable energy consumers in the borough to make similar large savings as those achieved elsewhere.

On being put to the vote the motion was declared carried and it was:

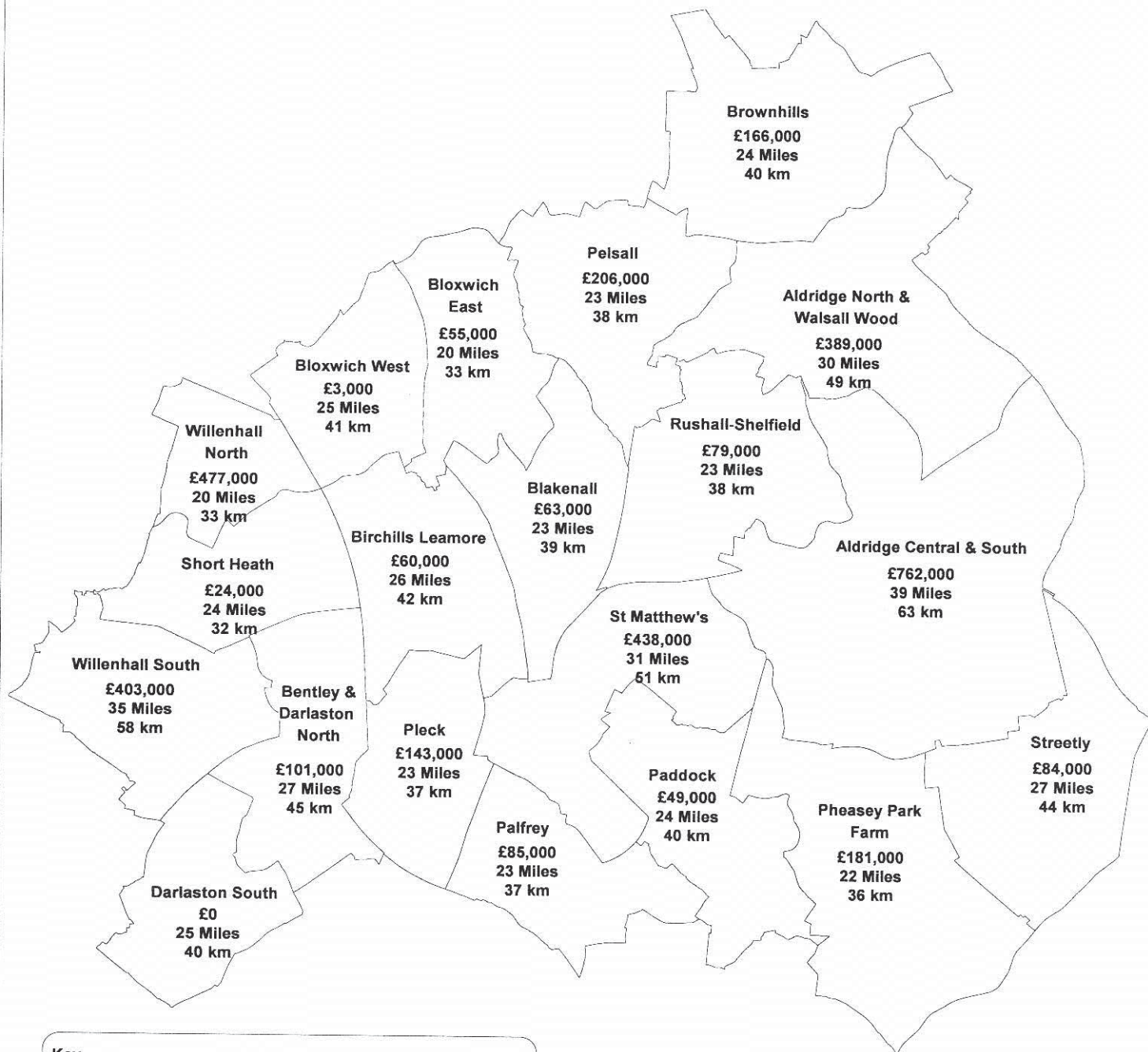

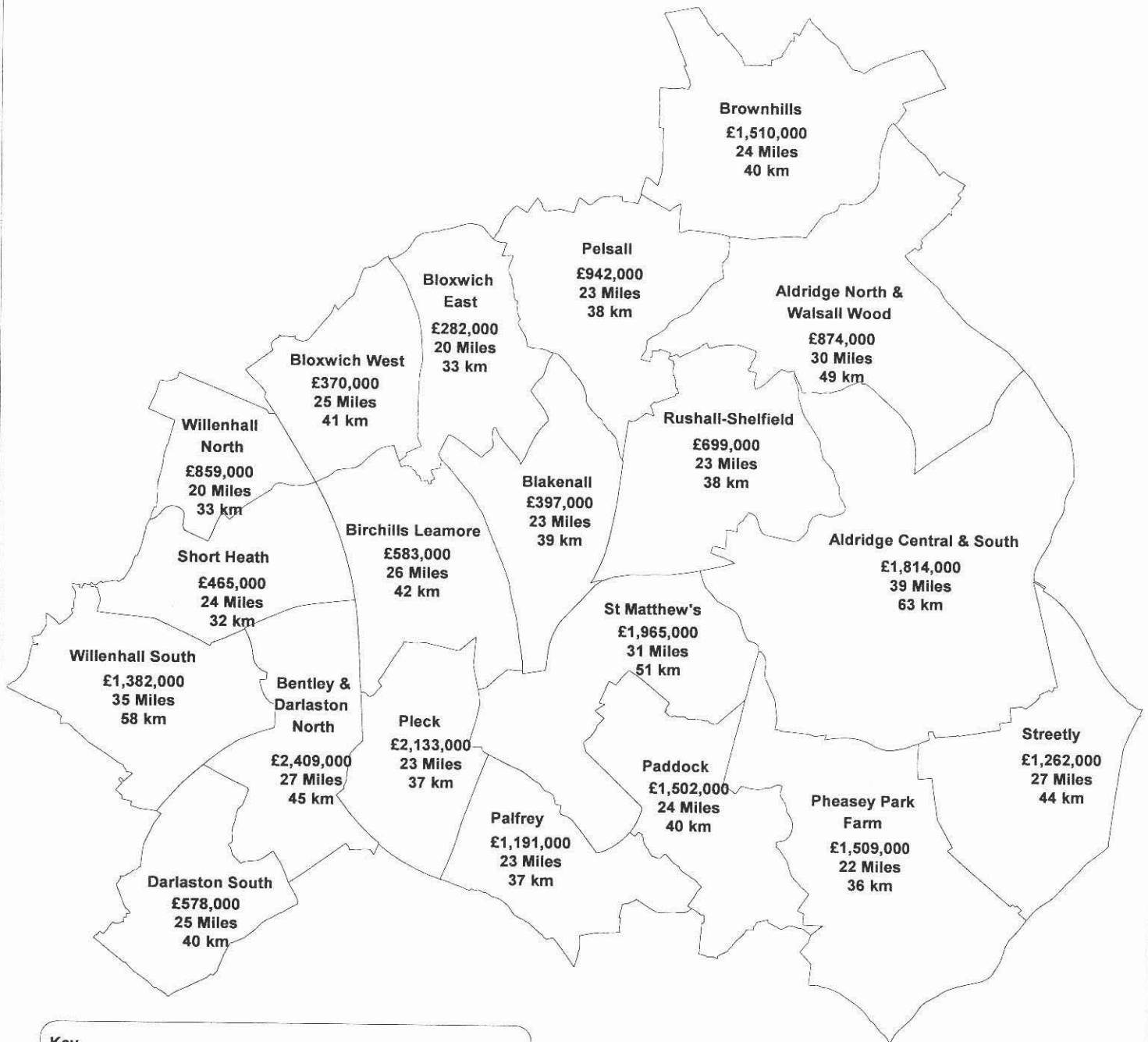
