Purpose of the report: To inform Schools Forum of the final sum recovered

from school balances as at 31 March 2009 and raise

awareness of the associated Audit Commission report "Valuable Lessons" and the DCSF/LGA survey

on school balances.

Recommendations: Schools Forum is recommended to support the work

of the LA proposed in this report to improve value for

money in Walsall schools.

1. Introduction

- 1.1 At the last meeting of the School Forum it was reported that the pressure remained on LAs to reduce school balances by using their balance control mechanisms, and that some surplus balances had been identified for recovery from Walsall schools. Since then, a number of issues have been raised, which has resulted in the value of school balances to be recovered.
- 1.2 In addition, over the summer the DCSF has carried out a survey of school balances and balance control mechanisms, with a view to making the process more robust. At the time of writing the report the outcome of the survey has not been published.
- 1.3 Also, the Audit Commission published a national local government report in July 2009, "Valuable Lessons - Improving economy and efficiency in schools". This report reinforces the messages around the accumulation of school balances representing poor value for money as well as referring to the need for councils to support schools in becoming better procurers. A copy of the executive summary is attached to this report
- 1.4 Another change now in place is the new OFSTED framework introduced on 1 September 2009. The new regime will seriously impact on how school's use their resources and achieve value for money in the future.

2. Recovery of School Balances

- 2.1 At the last meeting of the Schools Forum it was reported that a sum of £348,044 would be recovered from schools. Since then, the sum to be recovered has reduced to £170,273 due to further information being submitted by a number of schools, as expected. The main reasons for the reduction in clawback are the incorrect submission of year end data, that is, confusion between prior year commitments and properly assigned sums, and changes in circumstances, such as additional and unexpected costs on existing projects coming to light.
- 2.2 Two primary schools, one secondary school and three special schools have had balances recovered. The sums range from £1,670 to £107, 550. The total recovered of £170,272 will be used to offset the BSF/PCP contribution in 2010-11 as agreed by Schools Forum at the last meeting. A summary of schools balances per school, after the clawback of excessive balances is attached as Appendix 1.

- 2.3 At the last meeting it was also agreed that a sub group be set up o review the school balance control mechanism and members of the group were identified. As the DCSF and LGA have carried out a detailed survey on this topic over the summer it would make sense to defer the sub group until the results of the survey and the associated changes are published. The DCSF has been asked for an indication as to when this information will be available.
- 2.4 However, the potential delay does not prevent some work beginning around better use of resources and value for money in schools.

3. Audit Commission Report - Valuable Lessons

- 3.1 In July 2009 the Audit Commission published a national report "Valuable Lessons" improving economy and efficiency in schools, see the attached executive summary. The report came up with the following main findings:
 - Education expenditure per pupil has increased by two-thirds in a decade.
 - Schools have weak incentives to be economical and efficient.
 - Schools could save over £400 million through better procurement alone.
 - Workforce deployment is the most important decision in schools and must be undertaken with economy and efficiency in mind.
 - Many schools have excessive balances, of which over £500 million could be reduced nationally.
 - There are many ways schools can save money without adversely affecting children's education.
- 3.2 The report then makes a number of recommendations to be implemented by the DCSF, by councils and by the Audit Commission, which is charged with protecting the public purse. The summary recommendations are detailed on pages 4 to 7 of the executive summary report attached.
- 3.3 There are also separate briefing reports available for headteachers and school staff, school governors and councils. All chairs of governors have been provided with a copy of the summary report and the Briefing for School Governors, and all headteachers have been provided with the executive summary and the Briefing for Headteachers and School Staff.
- 3.4 This national survey carries a great deal of weight and it also supports the greater focus on value for money in the new OFSTED Inspection Framework. In future schools with large balances and also with pupils, particularly

vulnerable pupils, who have made insufficient progress, will be judged on this basis. Therefore, from the council perspective there is much work to be done in this area. The plans already underway are:

- The recruitment of a traded services and commissioning officer whose role will include driving this agenda forward in schools.
- Meetings are taking place with the DCSF and the Council regarding eprocurement options.
- As requested by headteachers, the setting up of a sub group to look at how the procurement of traded services can be improved.
- Internal Audit will include value for money when they begin their review of FMSiS in 2010-11.
- Complimentary training will be provided for both school staff and governors on managing resources and value for money.
- Greater liaison between school finance and advisory staff, including School Improvement Partners (SIPs)..
- 3.5 The report recommends that LAs consider funding the recommendations through, for example, traded services, refocusing resources on economy and efficiency, self-funding initiatives or persuading schools to invest in their own abilities to manage finances.

4. Recommendations

4.1 The Schools Forum is asked to note the content of this report and support the LA in the work to improve efficiency and economy in Walsall schools.
