Street Trading - Walsall Town Centre - Redesignation of Licensed Sites - Consultation

The report of the Interim Regulatory Manager was submitted:-

The Principal Licensing Officer (Mr. Knapper) enlarged upon the report for the benefit of the Committee. He added that the consultation exercise had been carried out and four responses had been received. None of the responses received were objecting to the proposals. He drew the Committee's attention to Paragraph 3.7 of the report regarding obtaining the consent of "relevant corporations" as defined within the Act. He stated that the Homes and Communities Agency were happy with the proposals and had given consent. However, there had not been a full and concise consent response from Network Rail Infrastructure Ltd., Until a full and complete response from Network Rail was received, the matter could not be progressed further.

Councillor Cook asked if there was a time limit for Network Rail to respond to the Council's consultation exercise. Dominic Patouchas, Legal Services, replied that there was no time limit set by the legislation. Network Rail were taking their time to indicate which streets they owned.

Councillor Douglas-Maul referred to the fact that street trading affected the image of the town. He referred to the market stalls and to the litter they created which let the town down. He understood that stall holders were supposed to assist the refuse collection operatives in clearing up the market but this was not happening.

Mr. Knapper explained the difference between market traders and the street traders who operated from seven sites around the Town Centre. He added that the street traders always removed their rubbish and there had been no complaints about them. He agreed that litter problems arose from the market traders.

Mr. Knapper reminded the meeting that any street trading applications would be referred to this Committee for determination. There were seven sites trading at present and under the existing regime, no further pitches could be added easily. It was hoped that if additional street trading sites could be offered, then the vibrancy of the Town Centre would be increased.

Councillor Burley referred to the comments made by the Traffic Management Team.

Mr. Knapper replied that if the Highways Team or Traffic Management Team raised objections to a street trading application, then the trader would normally withdraw it. If he/she did not, then the matter would be referred to the Committee for determination.

Councillor Burley suggested that consideration of this matter should be deferred until the consent of Network Rail had been received.

After further discussion it was,

That consideration of this matter be deferred until the consent of Network Rail has been received, then it be referred back to the Committee for determination.
