

## **Annual Council – 21st May 2007**

### **Constitution and timetable of meetings 2007/2008**

#### **Summary of report**

This report sets out a proposed amendment to the Constitution in relation to the chairing of the Scrutiny Management Board and the timetable of meetings to be adopted for the municipal year 2007/2008.

#### **Amendment to the Constitution**

At the meeting of the Scrutiny Management Board held on 12th March 2007, discussions took place concerning the present arrangements for the chairing of meetings of the Board. It was agreed that the Council at its annual meeting be recommended to agree to an amendment to the Constitution to allow for the chair to be elected for the duration of the municipal year as opposed to the position being rotated at each meeting and for there to be two vice-chairs reflecting the political balance of the Council.

#### **Timetable 2007/2008**

The draft timetable which is recommended for approval is attached as an **Appendix**.

The timetable has been prepared on the same basis as last year, with the exception of Cabinet which has been scheduled to meet on a monthly basis in order to link in more appropriately with the publication of the forward plan.

It is also proposed that the Development Control Committee meet at 5.30 p.m. instead of 6.00 p.m. when individual reports on matters other than development control issues are under consideration and that the Constitution be amended accordingly.

Although Local Neighbourhood Partnerships are not Committees of the Council the dates have been included in the timetable for the convenience of members' diaries.

In order for business to be administered in the most effective way possible, it is important that once the timetable is agreed by the Council, only in the most exceptional circumstances should meeting dates be re-arranged.

## **Recommendations**

- (1) That the Constitution Part 3, Responsibility for functions, Table 2, paragraph 18 relating to the Scrutiny Management Board be amended as follows:

### **Chairmen and Vice-Chairmen**

The office of chair will be for the duration of the municipal year with two vice-chairs being elected for the duration of the municipal year to reflect the political balance of the Council.

- (2) That Development Control Committee meet at 5.30 p.m. when matters other than development control issues are under consideration and that the Constitution be amended accordingly.
- (3) That the timetable of meetings for the municipal year 2007/2008 be approved.
