5.	Adoption of Black Country Core Strategy This report is presented to the Panel to consider the Cabinet report that is scheduled for 15 December 2010. It is proposed that Cabinet should recommend to Council on 10 January 2011 that the Core Strategy be adopted as part of the development plan for Walsall (as well as for the wider Black Country). This should be as of the same date it is adopted by Dudley, Sandwell and Wolverhampton councils, which is envisaged to be in early February 2011. The report explains the importance of adoption of the Core Strategy (JCS) for future decisions on planning applications, infrastructure and the Council's capital programme. The JCS will form the starting point for the production of detailed "daughter" development plan documents that will set out site-specific proposals.
