Projects Updates

- **Collingwood Centre & Park Hall CA:**

Both CA's have provided a breakdown of where the money will be spent. The CA's will be using the finances to complete refurbishments allowing their services to be more appealing and accessible to local users.

A memorandum has been sent to Lifelong Learning indicating the sum of £8000 has been transferred, £4000 for each CA. That department will now filter the funds down to the Collingwood Centre and Park Hall

- **Community Bus:**

Parpinder Singh and Sharon Froggatt met with John Elliot (Chief Officer of Community Transport) who has now provided a breakdown of the costs involved and what the project will achieve. The project proposal form has been completed and has been forwarded to Julie Ball. She will meet with the relevant service area to discuss project and identify next steps.

- **Doe Bank Park ‘Skate Park’:**

Awaiting a reply from Terry Blyde. Environmental regeneration has indicated they may be able to complete a feasibility study around the possibility of a skate park. Imke Goalby will speak to Steve Lewis

- **Graffiti removal:**

Ward councillors provided 2 locations where graffiti needs removing this included shops on Collingwood Drive and the cash point by the Post Office on Treyamon Road.

Phil Mateley (Street pride) is currently verifying ownership of the sites in question. Parpinder Singh is in correspondence with Caulie Grant from Street Pride to keep up to date on progress.

- **Chuckery Green:**

Cllr Sanders has been on a site visit with Simon Tranter (environmental regeneration), Simon advised that a brief consultation takes place with the local residents before the goal posts are adjusted.

- **Barr Beacon Historical Survey:**

Parpinder has been liaising with Diana West from Lifelong Learning in regards to this project. She has provided 2 possible projects.
