Summary of report

Feedback from workshop on 15th September

The LNP held a workshop on the 15th September to look at the issue of youth engagement. In addition some actions under the liveability theme were also discussed.

Youth Engagement – The LNP previously suggested that they could allocate £5000 towards youth engagement, but only after Young People of the area had been engaged allowing them to establish their views. At the previous meeting members agreed to invite Youth Opinions Untie (Y.O.U) to gain their perspective and advice on how best to engage young people.

Members from Y.O.U attended the workshop and provided interesting discussions on methods of engagement Y.O.U. agreed to conduct a consultation with young people to gain their views on what facilities they would like to see in the area and how best the LNP could spend the allocated resource. Y.O.U will report back results of the consultation at the January LNP meeting as the consultation will not be complete by the October meeting.

Members agreed the previous agreed action of young people observing a LNP meeting was a good idea, Y.O.U will arrange for this to happen for the January meeting.

Liveability – members discussed the issue of where the tPCT can locate their mobile screening unit. Sharon Froggatt informed that the entrance to the Collingwood centre was not wide enough to accommodate the mobile screening unit and requested financial support from the LNP to widen the entrance. Other possible sites suggested were St Martins Church (Paddock), Broadway Centre (next to Broadway pub) and Chuckery School.

Partnership Plan Review workshop

To assist with the 12 month review of the partnership plans, it is suggested that each LNP holds a workshop for their area. This will provide an opportunity for the LNP to revisit the current actions in the partnership plan, review the statistical data, and update the information from partner organisations. As a result the LNP will be able to develop a clear set of actions and pledges for the next 12 months that will demonstrate how they are making a difference and having an impact at a local level.
