<p>The Prevention of Public Nuisance</p> <p>I have to listen to the music/base I have been trying to get this looked into with the Environment team another Bar right underneath me would be unbearable as it's a listed building so we don't have double glazing and this Bar is directly under my flat I can only imagine the general public congregating until all hours, they had an event a few weeks ago and the music was so loud it was on till mid-day till 12pm and I really struggled imagine having that music playing every day it would be a nightmare.</p>
<p>Public Safety</p> <p>As Ive already explained fights occur this Bar would also attract fights and as its right outside I am scared to leave my building sometimes as there are groups of genral public hanging around, this would cause me even more stress and I would not feel safe the amount of fights I have had to witness is unbelievable.</p>
