1. Aim

1.1 This report seeks the Leader of the Council's approval for the Council to continue to order, source and enter into contract for Personal Protective Equipment (PPE) for emergency use during the COVID-19 pressures. Approval is sought to order items for a collective rolling monthly sum of no more than **£660,000**. This amount is based on retrospective and the estimated projected monthly costs alongside demands.

2. Summary

- 2.1. The Council is working alongside a whole range of partner organisations, in an attempt to help to minimise the spread of COVID-19. With regard to this request, it relates specifically to the purchasing of PPE to support local Care Providers, citizens, family carers and the Council front facing workforce employed within the Children and Adult Social Care directorates. As an employer the Council has a duty of care to provide a safe system of work for its own employees which would include using its best endeavours to ensure that they have the necessary equipment to carry out their duties safely. This is also relevant in terms of addressing Health and Safety issues.
- 2.2. Ordinarily, the local independent sector providers that deliver care and support across Walsall take responsibility fully for their ordering, supplies and payment of PPE.
- 2.3. As a direct result of the Coronavirus Pandemic, and the corresponding surge in demand for PPE, the local supply chains for providers have become increasingly difficult to access and the resources that are still available to providers locally, are increasing their prices along with their timescales for delivery.

- 2.4. National Health Service England (NHSE) and Public Health England (PHE) have issued guidance in relation to both the safe use of PPE and specifications of items sourced, alongside the process by which Care Providers can work to source supplies.
- 2.5. Regional Heads of Procurement and Regional ADASS colleagues from 14 Local Authorities are lobbying and scoping new ways of securing supplies and have developed a robust process and governance. On a regional level, there have also been several initiatives that strive to unblock the much needed arrival of stock, whilst ensuring the items are purchased in a cost effective way, from suppliers who are able to be a continuous supplier.
- 2.6. Walsall has received around 65 different donations from local businesses and citizens in relation to PPE supplies. The local offer has been greatly appreciated and the relationships and ongoing dialogue with those businesses and suppliers who are coming forward is very much appreciated. However, the enormity of the demand for safe specification and affordable supplies means that there remains a requirement for the Council to continue to secure orders, to do that promptly and in a way that gives us a good regular supply for prompt re-distribution across our Walsall providers and citizens.
- 2.7. Walsall Council is coordinating its supplies and distribution of PPE through a central 24/7 Hub based at Goscote. There are currently 164 different Care Providers that the Hub is supporting, 57 of those are Residential/Nursing homes in Walsall, 107 are Providers delivering a selection of Extra care, Supported living and domiciliary care provision. In addition, the Hub supports volunteers requiring PPE, internal workforce delivering a range of personal care and front facing work with vulnerable people, Direct Payment recipients and carers who may require PPE to support people at home.
- 2.8. Walsall Clinical Commissioning Group (WCCG) are working collaboratively with the Council, they supply PPE to all of the GP practices who are not receiving their PPE supplies via the NHS supply chain, they support the PPE supply for all Primary Care settings. Walsall Healthcare Trust (WHT) also has its own arrangements for their staff. Both WHT and WCCG will share their stock with Walsall Council where there is urgent need for supplies. This arrangement is working well.
- 2.9. There are ongoing discussions between WCCG and Walsall Council about the possible recharge of costs incurred for PPE by the Council to the CCG. NHS England have agreed in principle that costs can be recharged, however the CCG are currently in discussion with NHS England as to the value of that recharge. As such, there is no certainty that the Council will be able to recover the full costs.
- 2.10. In the absence of the clarity on recharges, there is an urgent need to seek approval from the Leader for the continued expenditure for orders of PPE stock.

3. Recommendations

- 3.1 That the Leader approves:
 - 1. The continuous ordering of urgent supplies of Personal Protective Equipment for up to a three-month period, continuation of current arrangements will be

subject to further review, including further clarification concerning the principle of recharging the CCG for this cost.

- 2. That the amount approved per month for the known existing demand does not exceed £660,000 per month and that any recharges that can be made to the Clinical Commissioning Group are processed as soon as this is practicable.
- 3. That any additional expenditure that may need to be requested in order to support wider cohorts of people or service areas, namely, Police, Funeral Directors or schools, is sought as a separate decision.
- 4. That approval is given to the Director of Adult Social Care to enter into contract directly with suppliers for the provision of emergency Personal and Protective Equipment supplies, using the most appropriate compliant procurement route, for a period of up to 3 months from 1st March 2020 to 31st May 2020
- 5. That approval is given to the Director of Adult Social Care to enter into collaborative contracts that are commissioned by other lead Local Authorities within the West Midlands region, for the provision of emergency Personal and Protective Equipment supplies, using the most appropriate compliant procurement route, for a period of up to 3 months from 1st March to 31st May 2020.

4. Report detail - Know

- 4.1. A National shortage of essential PPE items is currently creating increased pressure locally to support the care market and essential keyworker roles across Adult Social Care and Children Social Care Directorate.
- 4.2. Locally there is a sourcing and distribution site at Goscote in house Provider resource that is managing local requests and deliveries of PPE stock to all Providers, volunteers; Direct Payment recipients and internal keyworkers for social care, struggling to source PPE through their normal Business as usual routes.
- 4.3. National guidance in response to the Covid-19 outbreak, released on 19 March 2020, and subsequent updates has made it difficult to predict demands as well as ensure all providers are aware of when and how to source and use their PPE.
- 4.4. The need to source PPE on behalf of the marketplace across Walsall and its internal workforce relating to social care is a direct result of the Pandemic and the increased demands across the national, regional and local landscape for safe stocks of PPE.
- 4.5. There has been a surge in demand as more people become unwell or show signs of COVID-19. This alongside the diminished stocks across the country and the focus of local supplies going to the NHS, means there is little opportunity for providers to secure reliable deliveries of stock to keep themselves and their dependent population safe.
- 4.6. Walsall Council have received six ad hoc deliveries of PPE since the end of March 2020 as part of the National Supplies Disruption support, however this is not sufficient to support the whole of Walsall residents requiring care and support. The fifth consignment delivered to Walsall only contained a small supply of hand sanitiser.

4.7. Walsall Council have been able to support the gap in provision as it has purchased alternative stock in the absence of usual suppliers. This needs to continue now more than ever as the usual suppliers are really struggling to deliver and acute settings are being prioritised for national supplies.

Council Corporate Plan priorities

- 4.8. This proposal supports the Council's urgent and emergency response to the Covid 19 pandemic and the role the Council plays in the wider system of health and care for the people of Walsall.
- 4.9. This proposal links to the Council's corporate priority 'Communities are prospering and resilient. The most vulnerable are protected from avoidable harm, including treating and caring for people in a safe environment through working within the local community. It enhances quality of life for people with care and support needs and those with long term conditions; out of hospital, community based provision provides a safe and more appropriate environment for individuals recovering from ill health and/or injury or requiring long term care.
- 4.10. The proposal also links to emergency planning and resilience. Delivering a steady flow of supplies to the people who require it also means that Walsall are working in a similar collaborative way as its Regional partners. It means we are seeking the Best set of outcomes, cost effectiveness and some sustainable outcomes to see Walsall through an unprecedented time as a result of COVID-19 and the pandemic.

Risk management

- 4.11. There are no alternative options currently for providers and local people requiring PPE due to personal care and support needs. If the supply chain is eased by regional/national initiatives that unblock the extended problems encountered by, all relating to PPE, then there will be no further requirement for the Council to purchase on behalf of local people. The amount requested is based on retrospective and future estimated costs. It is also based on existing cohorts of Walsall residents with care and support needs.
- 4.12. The monitoring of the expenditure will continue to be overseen by distributors; procurement and finance colleagues. The agenda is also discussed daily as part of the COVID-19 chain of command groups (BRONZE: SILVER and GOLD), which has representatives of all internal and external Stakeholders responsible for delivering safe outcomes as a result of COVID-19.

Financial implications

4.13. Walsall Council will order safe supplies of PPE at a cost of no more than £660,000 per month for 3 months commencing March 2020, a total cost of up to £1.98m. There are ongoing discussions between WCCG and Walsall Council about the possible recharge of costs incurred for PPE by the Council to the CCG. NHS England have agreed in principle that costs can be recharged, however the CCG are currently in discussion with NHS England as to the value of that recharge. As such, there is no certainty that the Council will be able to recover the full cost.

Procurement Implications/Social Value

4.14. The Value of the contracts referred to in this report is above the current EU Threshold for Supplies (£189,330). Continued support will therefore be sought from the Council's Procurement Team to ensure compliance with Public Contract Regulations 2015, the Council's Contract Rules.

Legal Implications

- 4.15. The Council is already purchasing PPE in accordance with the arrangements with its partner agencies the CCG and WHT since March 2020. The council should continue to work with its procurement section to ensure that it secures best value in relation to ongoing purchases of PPE and that this is in done in accordance with the council's financial and contractual rules.
- 4.16. As an employer the Council has a duty of care to their employees, which means that they should take all steps which are reasonably possible to ensure their health, safety and wellbeing. This would include following national guidance regarding PPE.

Health and wellbeing implications

4.17. It is not in the public interest nor that of the Providers to not support the ongoing sourcing of PPE during this current crisis.

Staffing implications

4.18. There are no staffing implications arising out of this report.

Reducing Inequalities

4.19. An Equality Impact Assessment (EqIA) has been completed and can be found as an appendix to this report.

Consultation

4.20. All Social Care providers across Walsall and the Councils Health and Care partners are engaged in regular discussion in relation to PPE issues and requirements.

5. Decide

5.1. The Leader of the Council is requested to consider the content of this report and to agree the recommendations as outlined in section 3.

6 Respond

- 6.1. Subject to the Leader's decision under emergency powers, Council Officers will continue to source and fund PPE up to the total monthly sum of no more than £660,000 per month for 3 months.
- 6.2. Discussions will continue with the CCG for their full clarity and agreement to recharge costs to them for the cost of the PPE for Social Care.

7. Review

7.1. The arrangements with regards to the ordering and supplies will be managed and reviewed in line with ordinary Council procedures.
