#### 3334 Pre-audit outturn 2014/15 and resource allocation 2016/17 to 2019/2020

That Cabinet:

- Note the revenue carry forwards approved by the Chief Finance Officer (CFO) in consultation with the portfolio holder for finance, as set out in table 1 of the report.
- Note the capital re-profiling and carry forwards approved by the CFO in consultation with the portfolio holder for finance, as set out in the main body of the report and in appendix 2.
- Note the pre-audit revenue outturn overspend of £1.64m and the pre-audit capital outturn underspend of £350k. £340k of this capital underspend will be used to support the 2015/16 capital programme as approved by Council.
- Note the financial health indicators for 2014/15 summarised in Appendix 1
- Approve the proposed use of s31 grant as outlined in 3.5.

## 3335 Specialist health learning disabilities service – renewal of contract

Councillor Hughes presented the report:

With the agreement of the Cabinet, Councillor Longhi addressed the meeting. He referred to paragraph 7.3 of the report which had indicated that as this would be a standard form contract, Legal Services had not advised on the form of contract or the general contractual arrangements. He suggested that, whilst it was a standard contract, it would be for a period up to 3 years for which Council would be the accountable body, and therefore the Cabinet should receive assurance from legal services prior to the contract being awarded.

The Head of Legal Services, Mr S. Portman assured the Cabinet that as legal services had seen and were satisfied with the standard contract for 2014/15, and as there was limited scope to change or vary the form of the contract, he said that legal services did not need to review the contract again as they would not normally comment on the service element. Notwithstanding this, he undertook to review the contract again.

Councillor Hughes said that assurance from Legal Services would be sought as part of the delegated decision.

#### Resolved

- (1) That Cabinet delegate authority to the Executive Director of Social Care and Inclusion in consultation with the Portfolio Holders for Care and Safeguarding and Public Health and Wellbeing to award, and enter in to a new contract, for a period of 1 year from 1 April 2015 to 31 March 2016, with an option to extend by up to 2 years from 1 April 2016, with Black Country Partnership Foundation NHS Trust for the provision of specialist health learning disability services.
- (2) That recommendation (1) be carried out in accordance with the most appropriate and compliant procurement procedures and subsequently signed or sealed in accordance with the Council's Contract Rules.

## 3337 Reprocurement of specialist advocacy services

He said that he had previously voiced concerns about the visibility of the 'voiceability' Complaints Advocacy Service and reiterated that the service needed to be publicised more. He urged the Cabinet to continue to press for this through the contract.

#### Resolved

- (1) That Cabinet delegate authority to the Executive Director, Social Care and Inclusion in consultation with the Portfolio Holder, Care and Safeguarding to enter into shared arrangements with Dudley, Sandwell and Wolverhampton Councils, to be led by Sandwell Council, for the procurement of independent specialist advocacy services including the establishment of a new collaborative framework for the period up to March 2020.
- (2) That Cabinet notes that Social Care and Inclusion will need to identify funding for these independent advocacy services from within their current approved cash limited budget prior to any procurement to cover the full period of the procurement.

## 3338 Support for living at home services (community based services)
