01/21 Apologies

Councillor Andrew submitted an apology for absence.

02/21 **Substitution**

03/21 Declarations of Interest and Party Whip

04/21 Local Government (Access to Information) Act 1985 (as amended)

05/21 Minutes of the previous meeting

Resolved:

That the minutes of the meeting held on 25 March 2021, as amended, copies having previously been circulated, be approved as a true and accurate record.

06/21 Petition: Riverpoint Estate, Willenhall.

The Committee considered a petition, which requested the Council to explore all options to compulsory purchase the land which runs between the Riverpoint Estate, Willenhall and the former Willenhall Sewage Works. The Chair outlined the format for the item and confirmed that the petition received more than 500 signatures. The Chair invited the petition organiser to introduce their petition.

Councillor D. Coughlan introduced the petition and was supported by Ester and Ian Whitehouse as local residents. The Committee were shown before and after pictures of the land in question and the history of the plot.

She highlighted the land was once a green haven filled with trees and scrubs which local residents enjoyed. Over the course of a weekend, trees and shrubs were removed and the land was flattened for development. She concluded that it was essential that the Council considers all options to save the land from development and restore the land to its original purpose.

The Committee noted that planning consent for the development of the Riverpoint Estate contained the requirements for the subject land to be landscaped. This was stipulated for a period of 5 years from the grant of consent for the retention of the landscaping. However, it was noted that this consent had expired.

Compulsory purchase powers (CPO) enables Local Authorities to acquire land compulsorily in order to carry out a function within in the public interest. Council Officers carried out investigations on the land in question and concluded that the Council had no plan or scheme for the land. As a result, the Council was unable to utilise CPO powers.

The Committee was informed of the following points from the Lead and Supporting Petitioner:

 The land was previously populated with trees and scrubs as the land was designed to be a noise barrier between residential houses and the Black Country route.

- Development of the land happened without notice or consultation with the Council or local residents.
- The Council's Green Space Strategy reinforced open green spaces and was critical for mental wellbeing.
- It was noted that it took 23 years for trees and wildlife to settle on the land. Overnight the land had been flattened which had a devastating impact on local residents.
- The land was sold and transferred to a housing developer.
- A discussion was held around consultation with the residents. In response, the Executive Director confirmed that there had been some confusion between the land relating to the petition and the original application for housing on the Riverpoint Estate. There had been no planning application in respect of the clearance of the land. However, as the owner appeared to be compliant with land use, there was no recourse for the Council to undertake enforcement steps.
- Some of the residents had witnessed threatening behaviour from the landowner.

Ester and Ian Whitehouse thanked Councillor D Coughlan, Councillor S Coughlan and Councillor Andrew on their support of the petition.

Following debate, it was moved by Councillor S Coughlan and Seconded by Councillor Jeavons that:

The Cabinet to explore all options to compulsory purchase the land between Riverpoint Estate and the former Willenhall Sewage Works.

On being put to the vote the motion was unanimously carried.

The Cabinet to explore all options to compulsory purchase the land between Riverpoint Estate and the former Willenhall Sewage Works.

07/21 West Midlands Local Transport Plan – Green Paper Engagement

The Committee received a presentation from David Harris, Transport Strategy & Place Manager at TfWM. He reported on the development of a new West Midlands Local Transport Plan and provided an update on developing a new Local Transport Plan.

The Committee noted that the development of the Local Transport Plan was a statutory function of the West Midland Combined Authority (WMCA). The last local transport plan was adopted in 2016, however, the West Midlands had undergone significant development and change.

A robust transport strategy was essential part of the West Midland's economic recovery post Covid-19 pandemic. The new local transport plan would enable a long-term vision for transport, set a policy framework and work towards addressing the climate emergency. The WMCA had made a commitment to be carbon neutral by 2041.

At this point, Councillor Kaur joined the meeting.

The West Midlands Transport Green paper was published on 6th July 2021, which sets out five 'Motives for Change' for transport:

- Sustaining economic success: Support the building of an inclusive and green West Midlands economy, through better use of existing infrastructure, land, technology and sustainable transport options.
- Tackling the climate emergency: Changes to where people travel to / from, reducing the frequency of travel and changing the vehicles we use to travel.
- Creating a fairer society: analysing land use, the availability and affordability of transport and the experience and usability of transport.
- Supporting local places and communities: Re-imagining local neighbourhoods, reducing dominance of transport and providing quick and easy access to key local services.
- Becoming more active: Enable safe, convenient and accessible walking and cycling opportunities and increase active travel for journeys.

A West Midlands Leaders Summit was scheduled for late September 201 to consider the approach for the new Local Transport Plan with a formal approval for summer 2022.

The Committee thanked David Harris for his attendance.

Response to the Petition: "Traffic Calming Measures for Pelsall Lane"

Ward(s): Rushall-Shelfield

Portfolios: Councillor Andrew - Regeneration

1. Aim

- 1.1. A petition has been submitted calling on Walsall Council to install traffic calming measures on Pelsall Lane. The hard copy of the petition contained over 500 signatures.
- 1.2. The Council's petitions scheme state that "if a petition contains at least 500 signatories the relevant senior officer will give evidence at a public meeting of one of the Council's Overview and Scrutiny Committees. The authority has determined that the response to such petitions must be given by either the chief executive, executive directors, directors or heads of service. The committee may also decide to call the relevant portfolio holder to attend the meeting."

2. Recommendations

2.1. This report recommends that the need for further engineering works on Pelsall Lane be considered as part of the annual borough wide road safety review.

3. Report detail - know

- 3.1. The B4154 Pelsall Lane is a district distributor road which runs from A461 Lichfield Road to the railway bridge at the point where the B4154 becomes Walsall Road. There are 250 residential properties on Pelsall Lane which is approximately 0.7 miles [1.1km] in length. A 30mph speed limit extends along the full length of the road. A plan showing the road can be found at Appendix A.
- 3.2. The Highways Act 1980 places a general duty on the highway authority to keep its highways reasonably free of obstruction and in a condition that allows the safe passage of people and goods. Section 39 of The Road Safety Act 1988 places a statutory duty for highway authorities to:
 - a) prepare and carry out a programme of measures designed to promote road safety;
 - b) carry out studies into accidents arising out of the use of vehicles; and Page 11 of 47

- c) take such measures as appear to the authority to be appropriate to prevent such accidents.
- 3.3. Section 90 (A to F) of the Highways Act 1980 is the current legislation that covers the introduction of all forms of vertical deflections on a carriageway. The Traffic Calming Act 1992 amended the Highways Act 1980 to permit the introduction other forms of traffic calming within additional sections 90 (G to I). Such measures are therefore permitted for the purpose of 'promoting safety and preserving or improving the environment'. The Highways (Road Humps) Regulations 1999 require three or more street lights to be present not more than thirty eight metres apart or to comply with British Standard (BS5489 1992).
- 3.4. The petition submitted makes the following request:

"Following several road traffic collisions in recent weeks, involving personal injuries and loss of life, we demand that Walsall Council installs additional traffic calming measures to reduce the incidents of excessive speed on Pelsall Lane to give better protection to road users and pedestrians."

Responding to Road Safety Concerns

- 3.5. The Council receive a high volume of requests for traffic and road safety schemes. The range of issues includes speeding concerns, collisions concerns and parking issues. A data lead approach is taken to prioritising the implementation of road safety schemes and a programme is collated for Cabinet approval each year.
- 3.6. All scheme requests are recorded, assessed and categorised. In the case of local safety schemes, sites should have a minimum of six personal injury collisions in the previous three years to be considered as part of this programme. This is indicative of the number of injury collisions which occur on an annual basis. The list of schemes far exceeds the current level of funding available. The traffic engineering team undertake the annual review of injury collisions to prioritise those schemes where road safety measures are likely to be most effective in reducing casualties.
- 3.7. Schemes that have a lower number of injury collisions are transferred to the promotion of community health and safety programme (PCHS) for further review. Schemes held in this programme are assessed with the a road safety aspect, but include the impact a potential scheme may have on improving access to schools, local shops and public open space. The schemes are then ranked in priority and will be delivered based on the availability of funding.
- 3.8. Pelsall Lane is monitored for speed and injury collisions between Rushall junction and the over bridge on McClean Way. There have been three slight collisions [collisions in which at least one person is slightly injured but no person is killed or seriously injured] and one fatal collision recorded in the last three years. Damage-only collisions are not routinely considered in the context of road safety.
- 3.9. Following the fatal collision in March 2021 road markings where renewed and slow markings added. The condition of some of the bollards on the central refuges (islands) along the route were also checked and were in good working condition at the time.

- 3.10. In March 2021, traffic surveys collating data with respect to vehicle speeds, volumes and weights were undertaken across the borough on the A and B road network. Speed data for Pelsall Lane indicates 85%ile speed (the highest speed recorded by 85% of the traffic recorded) of 35.8mph. It is understood that this is below the level where Police enforcement would be considered.
- 3.11. As indicated above, the Council review collisions resulting in personal injury on an annual basis. In a borough wide context, in February 2021, Pelsall Lane ranked 85th out of 102 Local Safety Schemes. As such, it was not considered to be a priority for delivery in the financial year from April 2021 to March 2022.
- 3.12. Details of the full Local Safety Scheme programme can be found at Appendix B.

4. Financial information

- 4.1. All scheme requests are recorded, assessed and categorised. In the case of local safety schemes, sites should have a minimum of six personal injury collisions in the previous three years to be considered as part of this programme. This is indicative of the number of injury collisions which occur on an annual basis. The list of schemes far exceeds the current level of funding available. The traffic engineering team undertake the annual review of injury collisions to prioritise those schemes where road safety measures are likely to be most effective in reducing casualties.
- 4.2. There are no engineering works proposed at this time and therefore no financial implications associated with this report.

5. Reducing Inequalities

5.1. The Council's road safety programmes of work provide all citizens using Walsall's highway network a standard of service which will maintain the safe passage of vehicular and pedestrian traffic so far as is reasonably practicable.

6. Decide

6.1. The Council has to determine a reasonable level of intervention in response to the concerns raised by the signatories of the petition detailed in this report. This needs to take into account the borough wide demand for road safety measures and the site specific data with respect to incidents and traffic speeds.


7. Respond

7.1. The need for further engineering works will continue to be considered as part of the annual borough wide road safety reviews. The fatal collision in March 2021 and measures that were subsequently implemented on Pelsall Lane will form part of the Council's considerations in February 2022.

8.1. The need for further road safety engineering works will be reviewed on an annual basis as part of the Council borough wide safety review. Any future road safety scheme proposals which are likely to impact residents and road users in the Barns Lane will allow a period of consultation and comment on the details of the scheme before implementation.

Electric Vehicle Charging Infrastructure

Ward(s): Borough-wide

Portfolios: Transport & Regeneration

1.0 Aim

1.1 As of October 2021, significant progress has been made towards installing electric vehicle charging infrastructure for residential use in Walsall. The aim of the most recent project is to install electric vehicle charging points on-street in residential locations, this will provide the opportunity for households without dedicated off-street parking to be able to switch to an electric vehicle. Whilst government grants exist for households with driveways and garages to install charge points on their property, this project will help fill in the gap for the population of Walsall who do not.

2.0 Recommendations

- 2.2 It is recommended that members provide feedback on the proposed electric vehicle charging infrastructure in Walsall.
- 2.3 Members are invited to suggest locations for electric vehicle charging points for future installation.
- 3.0 Report detail knowContext National & Regional PolicyIn order to meet our international obligations, such as the 2015 Paris Agreement and national policy of achieving net-zero carbon emissions by 2050, the UK government has announced a national ban on the sale of new petrol and diesel cars by 2030 (with plug-in hybrid sales permitted until 2035). In line with the recently released Transport Decarbonisation Plan.
- 3.2 In comparison to national government, the West Midlands is aiming towards a more ambitious date of <u>2041 for net-zero</u> carbon emissions.
- 3.3 Locally, <u>'Transport in Walsall 2017-2022'</u> indicates the need to tackle poor air quality, declaring a borough-wide Air Quality Management Area (AQMA). Excess nitrogen oxide (NOx) and particulate matter (PM) emissions from petrol and diesel vehicles are a recognised risk to public health in Walsall, as stated in <u>'Our Health and Wellbeing Strategy 2019-2021'</u>.
- 3.4 The shift towards electric vehicles over the coming years will require the support of local authorities whilst the private market cannot provide all the necessary infrastructure, such as slow on-street residential charge points.

Context – Black Country Ultra Low Emission Vehicle (ULEV) Strategy

In February 2020, the Black Country local authorities developed an evidenced ULEV Strategy to boost electric vehicle uptake. The Black Country ULEV Strategy was publicly consulted on from 10/08/20 to 09/10/20, then endorsed at Heads of Regeneration (HoR) and the Association of Black Country Authorities (ABCA) in February 2021.

3.6 Key findings:

- a. currently in Walsall, only 0.19% of cars are electric.
- b. at present, approximately 85% of the Walsall land area is further than 1km from the nearest publicly available chargepoint. Walsall has the lowest baseline of public charging infrastructure in the Black Country (19 sockets).
- c. the number of electric vehicles in the Black Country is projected to increase to 42,500 by 2025, less than five years from now. the required increase in public ULEV charging infrastructure for Walsall by 2025 will be:
 - 7kW (Standard chargers): 163 sockets
 - 22kW (Fast chargers): 47 sockets
 - 50 kW (Rapid chargers): 4 sockets
 - 150kW (Ultra Rapid chargers): 1 socket
- d. and, in Walsall, as a result of the 2030 ban, CO2 emissions are expected to reduce by 22.2%, NOx by 40.3% and PM by 62.1%, compared to 2019 figures.

Context - The 'On-Street Residential Chargepoint Scheme' (ORCS)

- 3.7 The objective of this scheme is to increase the availability of on-street chargepoints for electric vehicles in residential streets where dedicated off-street parking (driveways, garages) is unavailable. This removes the barrier of not having private off-street parking to switching to an electric vehicle.
- 3.8 The national funding allocated by the Office for Zero Emissions Vehicles (OZEV) for 2021/2022 is £20 million.
- 3.9 Delivery of infrastructure is required by March 2023 for bids submitted in the 2021/2022 financial year.
- 3.10 The funding will support 75% of the capital costs of installing charge points.
- 3.11 Priority will be given to local authorities who have not previously received funding, such as Walsall MBC.

Progress to date

3.12 Walsall MBC, alongside the other Black Country authorities, has submitted a bid to the ORCS fund to deliver 35 electric vehicle charge point sites, two sockets each, across the borough for a total cost of £338,712. OZEV will receive the bid on the week commencing 18th October 2021.

- 3.13 This first round of installing on-street electric vehicle charging infrastructure will support the goal outlined in the Black Country ULEV Strategy above, delivering 70 of the 163, 7KW sockets that are required by 2025 to meet projected demand.
- 3.14 Please see Appendix A for a list of the 35 charge point sites identified. This is still a flexible list subject to design work and public consultation. Potential backup sites are currently being identified in case any on Appendix A cannot be delivered.
- 3.15 Correspondingly, please find Appendix B for an accompanying map of where the 35 charge point sites identified would be installed.
- 3.16 Any installations will be subject to public consultation with residents and businesses in the immediate vicinity of each location. This will occur after grant funding is secured, which is expected in November 2021.
- 3.17 Walsall MBC will not seek to enforce electric vehicle charging bays with a Traffic Regulation Order, unless one is already present. The parking bay will be of use to both electric and non-electric vehicles, with the addition of signage indicating that electric vehicles can charge in that bay. Therefore, the installation of onstreet electric vehicle charge points should not limit parking availability for other types of vehicles.
- 3.18 Procurement will be led by Transport for West Midlands (TfWM) and be procured through an established framework for electric charging infrastructure.

 Procurement will be for a value above the ORCS requirement to allow for additional call-off from the same operator if further funding is identified in the future. This procurement is expected to go out to market in November 2021.
- 3.19 The contract length, revenue share to the council and cost to the end user of the charge point will be defined during the tender.
- 3.20 Due to the financial contribution of grant capital funding, and council match funding, Walsall MBC will have more control over the locations, costs to consumer, potential profit-share and other contract terms.

4.0 Financial information

- 4.1 Walsall MBC aims to deliver 35 charge point sites across the borough for a total cost of £338,712. OZEV will supply 75% of capital funding at £254,034 and Walsall MBC will match £84,678.
- 4.2 The £84,678 match funding from Walsall MBC will be spread over the course of two years (2021/22 and 2022/23) and will be taken from the Transport Capital Programme (there is a Cabinet-approved budget allocation of £50,000 in 2021/22, and a complementary amount will be sought in 2022/23).
- 4.3 Walsall MBC will enter into a concession contract with the charge point operator. The contract will state that the operator takes on the revenue costs for operation and maintenance of the infrastructure, thereby reducing the financial risk to the council.

5.0 Reducing Inequalities

- 5.1 Socio-economic factors have been considered when identifying sites to install electric vehicle charging infrastructure. This project aims to reduce inequality by addressing the gap left by the private market. Private charge point operators are driven by where populations will most likely take up electric vehicles first. Whereas this project takes a longer view, understanding that areas of relative deprivation within Walsall may not be the first to buy electric vehicles, but public charging infrastructure should be available in these communities. We aim for a balanced geographical spread of charge points across the borough. Once the second-hand electric vehicle market has matured and central government apply supportive measures, the up-front cost of an electric vehicle will become less of a barrier. Furthermore, the current project is small scale but in future rounds of funding equity concerns can be addressed in the wider roll out.
- 5.2 More broadly, the installation of electric vehicle charging points in Walsall supports the objective of developing sustainable places and communities due to facilitating a reduction in emissions and air pollution. Encouraging the take up of electric cars will contribute to the national and local net-zero agenda and support Walsall's Air Quality Management Area.

6.0 Decide

- 6.1 There are no direct decisions to result from this report.
- 6.2 Members are requested to review the charge point locations that will be created via the Council's ORCS funding bid and inform officers either in direct response to this report or on an ongoing basis if they feel there are locations around the borough which would benefit from the installation of charge points and where either there are no charge points or where the number or speed of charge points is currently insufficient to meet user demand.

7.0 Respond

- 7.1 The committee's feedback on the current project for electric vehicle charging infrastructure in Walsall will be reflected in the next steps including procurement and public consultation.
- 7.2 The committee's recommendations for locations of charging infrastructure will be considered by officers prior to the Council submitting bids to subsequent rounds of ORCS funding, and any other relevant future projects or funding streams.

8.0 Review

- 8.1 In order to obtain the grant funding Walsall MBC have had to submit evidence of spend and exact locations for installation for review by OZEV.
- 8.2 Once delivered, the charge point sites will have to be added to the national chargepoint registry.
- 8.3 The <u>data on the usage</u> of the charge points must be submitted to OZEV for three years from the date the sites become operational.


