Measures and progress report for priorities under the Health and Wellbeing Strategy theme: 'Give every child the best start in life and enable them to make the most of who they are.'

1. Purpose

In order for the HWB Board to assure itself of current progress against priorities, the performance dashboard information has been continued and its presentation further developed to increase clarity and to increase alignment of production effort with other aspects of the Children's quality assurance framework reporting hierarchy.

2. Background

There are 6 priorities identified under this theme, all of which are priorities shared with the Children and Young People's Partnership Board, the Public Health Programme Board or the CCG's Mental Health Programme Board. Progress against the agreed measures is tracked and commentary has been updated where possible - since the awareness of need and the appointment of appropriate resource to support this.

3. Recommendations:

- That the Health and Wellbeing Board considers the performance dashboard as presented and considers whether adequate progress is being made against the measures.
- Whether the named lead Boards have adequate and timely corrective action plans in place to tackle underperforming areas, i.e. that the expected work is resulting in timely action / outputs and resultant impact.
- That the Board considers whether opportunities for collaborative effort are being maximised, for example:
 - are all relevant agencies aligning effort around tackling childhood obesity?
 - Are the opportunities to improve the outcomes of children through multi-agency early help work being made the most of?

4. Report detail

Overall, numeric progress since the last measurements appears static or good for all measures except childhood obesity (n.b. exceptionally high coverage) though Walsall remains in the bottom quartile nationally around the development of the most deprived early years children, infant mortality and childhood obesity.

Following the detailed report to the last meeting, an updated dashboard is provided for consideration by the Board. The former dashboard has been split into two sections: one where aspects are expected to change for each report and the other where fairly static information should be the norm. This is intended to support the Board in focusing on those areas that require challenge or where there may be opportunities for further collaborative support. An Information Analyst for Partnership Performance, Gemma Russell, was appointed to Children's Services in June 2015 and will be supporting the performance monitoring of a number of partnership based governance bodies, including the Health and Wellbeing Board. Increasing alignment with the reporting methodology in operation for the various governance bodies (collect once, use many times) will increase effectiveness and reporting arrangements.
