# <u>Deed of Variation to Tesco Store Legal Agreement</u> <u>Planning Permission reference 06/0367/OL/W7</u>

#### 1.0 PURPOSE OF REPORT

To advise on an approach to vary the section 106 agreement governing this development.

### 12 BACKGROUND AND REPORT DETAIL

- 12.1 The new college is now complete and operational and construction has commenced under the provisions of the Reserved Matters submission which Members approved (references 09/0921/RM and 09/0917/FL).
- 12.2 The completed legal agreement included a clause for the delivery, by Tesco, of a scheme of works relating to public art. The wording of the clauses stated the following
  - '5.3.1 Prior to the commencement of works to construct the New Store to submit to the Council a scheme of works for the provision of public art either within the Site or in the vicinity of the Site.
  - 5.3.2 To ensure that the scheme of public art approved by the Council pursuant to Clause 5.3.1 is completed prior to the Occupation.'
- 12.3 Since that agreement was signed, the Designing Walsall SPD has introduced an alternative approach to the delivery of public art, by collecting the money and deploying it centrally. Tesco have offered to vary the approved S106 to offer a financial contribution of £50,000 for the Council to deliver a scheme of public art.
- 12.4 Therefore Officers propose the clauses are amended to state the following:
  - 1. A contribution of £50,000 is provided to the Local Planning Authority on completion of this Deed of Variation to provide a scheme of public art on or within 800m of the boundary of the Site.
  - 2. Unless otherwise agreed by all parties the scheme of public art will be implemented within 12 months of the first occupation of the new store.
