52. **Apology**

53. **Minutes**

57. **Questions**

Removal of weeds from the highway

Councillor Shires asked the following question:

“In welcoming the belated attempts by Clean and Green at removing the build-up of weeds on our highways as a direct result of budget cuts agreed by Cabinet ahead of the Special Budget Council meeting in February of this year.

I would like to ask the following question of the portfolio holder for Clean and Green:

Can he share with this Council the schedule of which roads have, to date been cleared of weeds, and the plan going forward to clear the remaining roads in the borough and how the priority in which the work is being carried out was decided upon; and

How much funding has been set aside to complete this task and from where the funding was sourced. Given the fact that this is extra work than what was originally planned, what planned work will now either be delayed or cancelled?"

Councillor Butler replied:

- (a) Reducing highway weed spraying to once per annum has allowed weed growth to flourish. Control of weeds on roads and pavements is linked to street cleansing activities. Regular sweeping removes detritus in which weeds can grow and prevents seedlings from maturing.

Perennial and annual weed seeds can establish themselves to a mature plant in as little as six to eight weeks. The growing season traditionally has ranged from April to October, however this is notably being extended from March to November given milder weather conditions. In a 30-week growing season, three generations of dandelions can grow.

Weeds are being removed in accordance with the ongoing planned cleansing schedules across the 20 wards and detailed on the Council's website. This schedule ranges from three times to nine times per annum depending on ward and levels of deterioration.

This cleansing programme will continue and include the removal of weeds within existing available resources.

This year's annual herbicide treatment was undertaken by an external contractor. Work commenced on 10 June 2019 and was completed within six weeks. A five day return visit was undertaken in mid-August to address concerns over weed kill rate. The treatment is a contact herbicide (glyphosate) that kills existing visible weed growth. This treatment does not kill or prevent weed seeds from establishing.

- (b) The 2019/20 weed spraying contract cost circa £13k. Funding for weed removal comes from existing street cleansing budgets and is carried out by existing resources as part of the scheduled deep cleans. Cleansing work, including weed removal will continue in each scheduled area over the allocated four-day period and be focussed on the area of most need. This work will be supported by the channel sweeper with more aggressive brushes, removing weeds from the highway channel which will improve drainage, particularly in periods of heavy rainfall.

Budgets for weed control have been significantly reduced over recent years, resulting in only one spray in 2019.

As agreed by Cabinet in September, budgets will be increased in 2020/21 by £55k allowing three sprays which will be carried out at optimum times to minimise the visible weed growth. Additionally, increased herbicide treatments will take place in car parks and other council maintained locations.

Community payback teams will also be used to work with Clean and Green to strengthen operative numbers.”

Councillor Shires asked the following supplementary question:

“When were the footpaths cleaned and how much did it cost”?

Councillor Butler replied:

“The footpaths were cleaned in March 2019”

Therefore this Council requests that officers undertake a review of all roads with a view to reducing the need for grass cutting wherever possible and areas seeded with wildflowers subject to the maintenance of satisfactory sight lines for drivers and pedestrians.

Further that consultation on the recommendations of this review be the subject of a Community Consultation through each of the four Strategic Locality Partnership Boards (SLPB). That the feedback from the four SLPBs be referred to the Economy and Environment Overview and Scrutiny Committee as part of the pre-decision scrutiny process before going to Cabinet.

- Improve bio-diversity
- Provide areas for pollinating insects
- Add to the visual amenity appeal of many of our main thoroughfares
- Saves money which can be used for other environmental activity.

64. **Notice of motion – Kashmir**

The following motion, notice of which had been duly given was **moved** by Councillor Nawaz and seconded by Councillor Hussain:

This Council recognises the worry, anxiety and heartfelt concern felt by residents of Walsall, particularly by the substantial Kashmiri community in the Borough who have relations in Kashmir, on the continuing human rights abuses being committed by Occupying Indian Forces in Kashmir.

This motion calls upon the Council to condemn strongly:

- The widely reported abuse of Kashmiri men, women and children by occupying Indian Armed Forces
- The lock down of Kashmir – resulting in the imprisoning of 8 million people within the occupied territory
- The arrest of the Kashmiri Political leaders by occupying Indian authorities
- The widely reported continuing persecution and forced conversions of minorities by the Indian Government led by Prime Minister Modi.

This Council therefore calls for:

- Walsall Council to write to the Foreign Secretary and the Prime Minister to express the concerns of Walsall residents, particularly those of Kashmiri heritage, regarding the ongoing reported abuses against the people of Kashmir by Indian Armed Forces caused by the policies of the Indian Government.
- That Walsall Council call upon Walsall's Members of Parliament to publically condemn the abuses of the Kashmiri people by Indian Occupation Forces and support the right of self-determination for the people of Kashmir and the removal of Indian armed forces from Kashmir.

Amendment moved by Councillor Bird and seconded by Councillor Andrew:

This Council recognises the worry and heartfelt concern felt by the residents of Walsall, particularly the substantial Kashmiri community in the Borough, and therefore this Council requests that officers write to the Foreign Secretary and the Prime Minister to express the concerns of Walsall residents, particularly those of Kashmiri heritage with regards to the situation in Kashmir.

Further, that this Council call upon Walsall Members of Parliament to publicly condemn the situation in Kashmir and support the right of self-determination for the people of Kashmir.
