RE: Sneyd

Purpose

To provide an update on the process of closing Sneyd Community school between 02 March to 05 April 2011.

1. Introduction

Formal reports have been made to Cabinet at its meetings on: 22 October 2008, 22 April 2009, 15 July 2009, 13 August, 21 October 2009, 13 January 2010 and 17 November 2010.

Reports have been made to Scrutiny at its meetings on:

2. Pupils

2.1 Pupil numbers

Pupil numbers have continued to decline because some pupils are transferring to alternative schools before the end of the current academic year.

Eight pupils in Year 9 have applied for a place at the UTC from September 2011 and conditional offers have been made. As yet, the Funding Agreement for the UTC has not been signed by

ministers; it is expected that this will be completed in the next two months. Firm offers of places will be sent following this.

Staff in Planning and Development Services are continuing to work with the families to support them through the transfer process.

3.3 Year 13

Pupils in Year 13 transferred to other schools during the autumn half term 2010.

4. Uniform and Travel

It has been agreed that assistance with the cost of uniforms for transferring pupils will be made available for Walsall pupils in Year 8 and Year 9.

Where appropriate, home-to-school transport arrangements are being made for pupils transferring to other schools from September 2011. Depending on the circumstances this may take the form of a bus pass or other arrangements.

5. Staff

Formal process has continued. Most staffing queries have now been resolved. Contract termination dates agreed as 31st July 2011 for support staff, with the exception of a few that will be required to remain until the end of August. All teaching staff contracts to be terminated as of 31.08.011.

Employees are engaging well in seeking alternate work and re-deployment opportunities.

6. Finance

The agreed early closure of the school should allow the school to remain in budget through to the 31 August 2011. Pupil numbers as at January 2011 School Census date were close to numbers used in the budget forecast. However, grant funding changes may have some adverse financial impact. Large reserves will be carried forward at the end of the 2010-11 financial year to support the school's budget during its last five months of operation, and every attempt will be made to ensure the school continues to meet the needs of the remaining pupils within its resources.

The Schools' Finance Team will continue to support the school leadership team up to the end of August 2011 to resolve all outstanding financial issues and undertake rigorous budget monitoring.

7. Curriculum

Key Stage 3

Pupils visited the Black Country Living Museum on 4th March as part of their Project Work. On 7th March the students were involved in First Aid Training which will give them an external qualification to take with them to their new schools. As there are only 20 students in Year 8 and 20 in Year 9 there has been one class in each year since 28th February, with 2 teachers in most lessons. This will assist the wide variation in ability and encourage more links to be made in the project lessons.

Key Stage 4

The school have worked with the Walsall Children's Services-Serco ICT consultant to identify cohorts of pupils who would benefit from his expertise, ranging from those already studying ICT to

ensure that they gain the most from their remaining time in the subject both as core and an option, to students who have English and Maths at Grade C or above but may not gain 3 other GCSEs. He has supported pupils and staff to ensure that pupils achieve their potential and in particular 5 A*-C GCSEs.

18 pupils participated in a week of Work Experience from 28th February for their BTEC Retail course.

Regular monitoring is taking place to ensure that all pupils have made applications to colleges or schools. The Information, Advice and Guidance Advisor has been very pro-active and is working hard to support pupils with applications and make contact with colleges to aid a smooth transition.

KS3 & 4

One-to-One Maths Tuition has been funded using 3 Maths tutors to support pupils at both Key Stages. 633 hours have been provided and 52 KS3 and 53 KS4 pupils have participated. Of the 28 Y11 pupils who had tutoring prior to the November Maths GCSE examination, 20 achieved at least a grade C, 26 of them achieved their target grade. Of 34 KS3 pupils who have completed their hours, 24 have achieved their target grade or above. 2 KS3 students are entered for Maths GCSE in the summer because they are currently working at grade C.

Inspection

During the Ofsted monitoring visit (23rd / 24th March), inspectors deemed the school to have made sufficient progress to no longer require Special Measures. Overall effectiveness in Ofsted terms is now satisfactory and HMI reported that progress is good for all groups of learners including those with special educational needs. Although attainment is below average, inspectors saw enough evidence to be confident that it is likely to become average by the end of the academic year. The final report is not yet published, but in the verbal feedback it was noted that the LA brokered partnership arrangement with Barr Beacon had been outstanding and had brought about considerable improvements

8. Governance

The IEB met on 28th February and 28th March. They have considered the progress of students and transition arrangements to other schools. The partnership support from Barr Beacon has been effective and is having a positive impact on the outcomes for students, particularly in mathematics. Staffing has been adjusted to keep within budget while assuring support for the students remaining in the school. Progress against the Ofsted recovery plan has been monitored.

9. Press

Walsall Council and Walsall Children's Services – Serco will continue to work together to ensure that the important information required by parents, carers and pupils is communicated. Statements will be issued, if required, in response to individual enquiries from the media.
