After considerable discussion, it was:-

Resolved

That the draft children and young peoples plan be noted and the following suggestions be incorporated therein, together with any further suggested amendments being notified to the Children's Services Section by 23 February 2006:-

- The plan needed to be easy to read;
- An executive summary should be included;
- More information was required on Looked After Children;
- A glossery of terms be included;
- Targets needed to be SMART;
- Bullying targets be included;
- · Provisions need to be made clear;
- The plan should be more balanced between pre 16 and 16-19 age range;
- The 10 point entitlement for all 14/19 years olds and the 14-19 white paper should be reflected in the plan;
- The plan should refer to the education white paper;
- Post 16 years be included and cross referenced to the Learning and Skills Council, the Learning and Skills Council logo be included on the front cover alongside "Connexions"
- Include percentage targets (not mixed);
- The diagram on page 9 needs to be more explicit;
- "Medium IPF" on graph should show a line and not a bar;
- The geographical variation (page 12) should indicate Wards;
- Link drugs and alcohol together.
